## **Income Tax Clinics for Low Income Families** Taxation Year: 2018

**Volunteer Chartered Professional Accountants (CPA Ontario) preparing personal tax returns** for eligible low income families at no charge.

#### **Criteria:**

- Must have a valid SIN or ITN (Individual Tax Number)
- Annual gross income not exceeding:

Individual/Single: \$35,000

⇒ Couple/single parent: \$45,000

- ⇒ plus \$2,500 for each additional dependant
- Interest income less than \$1,000 per family
- No foreign assets or income other than foreign pension
- No self-employment income or employment expenses
- No business or rental income and expenses
- No capital gains or losses
- No corporate or trust income
- No bankruptcy filed
- Not for the deceased within the year
